Job Description for the post of:

Casual Gymnastics Head Coach

Reporting to: Sports Development Manager

Accountable to: Head of Sports Services

To organise, promote and deliver a varied programme of coaching suitable for the target audience, involving the set up and dismantling of equipment and ensuring participants' safety and wellbeing throughout the session.

Main Duties and Responsibilities

- To plan and provide high quality coaching and instruction and up to date advice. This
 will include the children's coaching programme of 5 15 years, and may include some
 coaching of adults.
- To ensure Health and Safety standards are maintained and that all users are provided with safe and secure sessions.
- To lead a team of Assistant coaches in the preparation and delivery of sessions, constantly evaluating the effectiveness of the gymnastics programme in terms of progress and improvements of participants.
- To ensure sessions follow British Gymnastics guidelines in terms of session delivery.
- To ensure that gymnastics equipment is set up safely and securely and checked prior to each session, and reporting any issues to the Duty Manager.
- To undertake administrative duties as required by the role, in particular ensuring the completion of weekly written registers and attendances and providing monthly updates on individual participant's progress.
- To administer first aid as required (if qualified) and complete appropriate records.
- To notify the Duty Manager of any issues or customer complaints that may arise during activity sessions.
- To ensure that the highest levels of customer service are maintained at all times and provide assistance and advice to customers using the facilities.
- To act in a responsible and appropriate manner at all times in accordance with the British Gymnastics Code of Conduct, ethics and best practice, reporting any concerns to the Sports Development Manager

- Undertake appropriate training, development and attend meetings as required to ensure that qualifications are kept up to date.
- To undertake any other duties as required by the Sports Development Manager or a member of the Edge Hill Sport Management Team suitable for the grade.

In addition to the above all Edge Hill University staff are required to:

- Respect confidentiality: all confidential information should be kept in confidence and not released to unauthorised persons
- Undertake appropriate training and development as required
