If you are unsure as to the suitability of your course, or are thinking of leaving Edge Hill University please contact your Personal Tutor to discuss your options. If you do withdraw or interrupt, all scheduled bursary and scholarship payments will cease with immediate effect and the amount of tuition fee you will be liable to pay will depend upon the date you withdraw as confirmed in the Student Withdrawal Procedures.<sup>2</sup>
