About the Department

The Department of Law and Criminology offers a number of qualifying undergraduate Law degrees and Criminology Single Honours and Joints Honours degrees with Psychology, with Sociology, Childhood and Youth Studies and Single Honours degrees in Policing and Professional Policing. We also offer a number of Politics Joint degrees, as well as postgraduate degrees by Research in Criminology, Law and Policing.

About the Job

The successful candidate(s) will ensure that the modules conform to requirements of the legal profession and provide an excellent insight into working in the legal profession.
